If you are an organic farmer or want to transition into organic farming, contact your local NRCS office to see how you may qualify for financial assistance for conservation planning or practices such as the Environmental Quality Incentives Program (EQIP). Not only will NRCS staff outline the eligibility and application process, but they can address additional questions relating to ways you may further enhance the viability of your farming operation.

In order for a participant to receive payments for conservation practices related to organic production or the transition to organic production, the person must have an organic system

plan reviewed by a USDA accredited organic certifier.

An Organic System Plan is a management plan specifically designed for organic production or for an organic handling operation that has been agreed to by the producer or handler and the certifying agent. The Organic System Plan includes all written plans that govern all aspects of agricultural production or handling.

For those interested, current organic producers or those transitioning into organic production will have equal access for priority program assistance from NRCS.
